Terms and conditions renting sailing boats

1. Who can rent sailing boats?

Scouts Centre Harderhaven has sailing boats of the Lelievlet type, which can be rented by both members and non-members of Scouting. As the insurance of the sailing boats is part of a larger package of Scouting Netherlands, additional requirements for non-members are in place (see §§ 4. en 13.).

The renting party should have at least one person with sufficient sailing skills per boat. This should be of the level of the Dutch diploma CWO-KB3, or similar. This is to be verified by the Camp staff or somebody else of the management team of Scouts Centre Harderhaven (further designated as "Camp staff" or "Harderhaven"). Sailing boat rental is only possible when Camp staff is present at Scouts Centre Harderhaven.

2. How to make a reservation?

Sailing boats can be booked via the reservation form on the website www.harderhaven.scouting.nl. See also "Terms of payment". Sailing boats (if available) can also be reserved by guests directly from the Camp staff, if present on the Scouts Centre.

3. Time of usage

The reserved sailing boats can be used by the renters:

- If the boat(s) are rented for 1 day: from 9 o'clock in the morning till 1 hour before sunset (unless agreed otherwise).
- If the boat(s) are rented for more than 1 day: from 9 o'clock in the morning of the first day, till 1 hour before sunset on the last day (unless agreed differently).

4. Arrival signup

Before a sailing boat can be used by the renter, the leader of the group needs to report to the Camp staff. The renter can make use of the sailing boat if:

- A. The digital reservation form is in the possession of Harderhaven AND
- B. The sent booking confirmation is paid in full AND
- C. The Camp staff has assessed that on each boat at least one person is present with sufficient sailing skills.
- D. In case of Non-members, a copy of passport or ID-card has to be made by Harderhaven (see § 13).

When a guest is renting directly from the camp staff, requirements A. and B. are to be agreed by the renter and camp staff how the rental fee is to be paid.

The renter checks together with the Camp staff the sailing boat(s) for existing damages and that all equipment is present. Shortcomings or damages are noted on the rental form which is signed by both parties.

5. Special provisions regarding the insurance of the sailing boats

- A. The renter is not allowed to lend, sublet and/or relet the rented sailing boat(s).
- B. The personal properties of the renter are not insured.
- C. The rented sailing boat(s) may only be used on inland waterways.¹
- D. The own risk of the insurance is € 250,=

6. Accessibility

- A. Cars are not allowed on the site. This means not even for loading and unloading. Parking is only allowed outside the gates of the camp sites. Trailers, boat trailers, etc. can be pushed by hand on the camp site.
- B. Bicycles can be parked on the left side of the main gate upon entrance.
- C. The camp staff has a hand cart, which can be borrowed to transport materials.

7. Garbage

- A. Upon arrival a small blue garbage container and garbage bags are given to the tenant to use during their stay. Domestic garbage must be put in garbage bags and disposed in the waste container directly outside the main gate. For paper, cardboard, etc. and for glass separate containers are located at the inside of the fence at the main gate.
- B. Milk and juice cartons need be flattened and disposed in the general waste container.
- C. Paper and carton boxes needs to be flattened and disposed in the paper container
- D. All other garbage (tents, chairs, etc.) is not allowed in the general waste container and needs to be disposed by yourself (take it home or bring it to a waste relay station).

E. Garbage which is found outside the waste container after departure of the tenant, will be disposed by Harderhaven. The tenant will be sent the bill.

8. Liability

Scouting Nederland, Scouts Centre Harderhaven and her volunteers cannot be held liable for personal injury and/or property damage, in whatever form, associated with the use of the label terrain Harderhaven or the sailing boats

9. Terrain usage (general)

- A. The terrain, the paths and terraces on site should be kept clean. When leaving this must be checked and any cigarette butts, candy wrappers, etc. needs to be removed. The starting point is that building and grounds will be left neater as that is were when you arrived!
- B. It is not allowed to use the grass field in front of the main building for activities by tenants of camp sites.
- C. The usage of sound equipment is prohibited. In special cases can, after consultation of the camp staff, the usage be allowed.
- D. The use of the swimming water is at your own risk.
- E. Swimming in the area between the two main jetties is allowed. The quality of the swimming water is in general of good quality. Showering after swimming is always recommended.
- F. Fishing is allowed without a permit for juveniles (under 16 years of age). From 16 years and up, a fishing permit is needed!
- G. For all matters, which are not dealt within these regulations, you are obliged to follow the instructions of the camp staff.
- H. You can always turn to the camp staff when you have questions or remarks.

¹ The exact limitations can be asked from the management team of Harderhaven.

- I. Pets are not allowed on the camp sites and in the main building.
- J. The instructions given by the camp staff concerning your stay on the camp site and the cleaning of the toilet buildings need to be followed.
- K. The digging of holes and ditches in the ground is not allowed. For cooking fires you need to make a table fire. Afterwards all ash and wood pieces need to be disposed of.
- L. Campfires are only allowed on the designated areas, when the wind is not coming from northeast-southeast direction, sufficient extinguishing materials are present and the camp staff/caretaker is consulted.

10. General

- A. A first aid kit is present in the main building and in the Camp staff building. This can be used by the responsible leaders of the renting group.
- B. Harderhaven offers lifejackets for all members of the renting group (unless agreed otherwise). Lifejackets need to be worn by all persons on board of the sailing boat(s)

11. Fellow users and neighbours of Harderhaven

The Scouts Centre has often many people spending the night and is also located close by residential houses. Therefore between 23:00 hours and 7:00 hours it has to be quiet.

This means that during this period it is not allowed to leave or arrive on the jetty with a sailing boat.

12. Departure

At the departure the responsible person of the group or the renter will report to the camp staff.

The Camp staff checks together with the responsible person of the group or the renter the rented sailing boat(s) on the following points:

- That the sailing boat is correctly moored.
- Garbage has been disposed correctly.
- Rigging and equipment is complete.
- Rigging and equipment is stored correctly.
- If there are damages.

Shortcomings or damages are noted on the earlier mentioned rental form which is signed by both parties. Harderhaven will send an invoice for damages and lost equipment if applicable.

13. Copy of passport or ID-card

The insurance company requires that non-members of scouting provide Harderhaven with a copy of their passport or ID-card. The Camp staff can make this copy with the app "KopieID". A paper copy is also accepted.
